
Financial Statement

- Total assets amount to 8 billion yuan RMB, an increase of 29.03% compared with the end of 1996


The integrated remitting network linked with the other cities within the system of United banks has covered 36 major cities in the entire country on the basis of its commissioning in 1996.

The nation-wide electronic inter-banking business was put into service in June 1997, and all the branches were assigned the Inter-Banking Number. In combination with the existing channels of settlement, our Bank has preliminarily formed the relatively easy and unobstructed network of settlement with the banks in the same city and in the other cities as well as inside and outside the banking system, thus providing functional guarantee for the business growth of the entire Bank.
